## My submission is that:

I am an Environmental Engineer with MWH New Zealand Ltd. Since 2003, we have been engaged by the Hutt City Council to assist with the asset management of the trunk wastewater network that serves both HCC and UHCC. The designated site shown as HCC 2 on the planning maps accomodates a key asset in this network, which was developed in 2005 to provide a wastewater storage facility for the Councils. Future development of this site is likely to be required to meet new environmental standards and future growth. Due to the investment in infrastructure at this location it would not be cost effective or practicable to locate future associated assets at another site. While the existing designation provides for some additional storage other associated structures for related wastewater development at this site may not be sufficiently provided. I oppose the proposed change to Chapter 33 activity status and request an additional activity status to provide for appropriate development.

The existing Discretionary activity status in Chapter 33 for Building and structures in the 1 in 100 year flood extent provides for suitable controls on this land. The flood hazard can be suitably managed by engineering controls such as raising ground levels, providing waterproofed equipment, sealed doors and other mechanical protection as appropriate. I oppose the proposed change and request some additional wording in Chapter 16 to acknowledge that Utility development can be undertaken with appropriate controls.

I have discussed this submission with Bruce Sherlock, the Infrastructure Manager of Hutt City Council, and Lachlan Wallach, the Director of Infrastructure Services at Upper Hutt City Council and they support this submission.

I seek the following decision from the local authority:

Section 16.4.1 – add the following wording:

"Where it is not practicable to locate Utilities outside the Flood Hazard Area, any new Utilities within the Flood Hazard Areas should be designed to withstand the design flood event."

Section 33.1 – add the following activity:

Utilities (including associated buildings and structures) to be erected within the River Corridor, Overflow Path or Erosion Hazard Line as shown in the Hazard Maps in Part 5 of the District Plan **Discretionary** activity
