## **DETAILS OF SUBMISSION**

The specific provisions of the proposed Plan Change that my submission relates to are as follows:
The dramatic increase of river flow rates for the Hutt River that move from 1-100 year event to 1-440 year event as a bases for deciding River Corridors, Overflow Paths, Ponding Areas and Erosion Hazards.



My submission is that:

I have been the Gratton Farm Forestry property owner since 1971 when local administration was by the Hutt County Council.

This is a 200Ha property with long frontages to the Akatarawa River, which at times flood, so living and coping with the river is something we are used to.

While our property is not directly affected there are a number of issues we would comment on.

1 Our access is from 6A Bridge Road which is affected by changes in the flood ponding and erosion hazard maps affecting properties down the Road.

Those properties were built complying with relevant building codes placing them above flood zones in force at the time.

It is one thing to have guidelines for a 100 year flood but any changes to increase that flood event height must be seen as fair and reasonable and achievable to implement.

To go from 372 cumec to 2300, ie 3000 year flood event is not fair to those property owners.

In the 40 odd years of my experience here, we have experienced a 75 year flood event in either the Akatarawa or the Hutt Rivers. So a 100 year event has not being experienced in this region in my time. Any changes to the flood level height at the Upper Hutt twin bridges area will be magnified at the Lower Hutt River end.

If changes are necessary then increase the 100 year guideline to 150 year level, this seems a compromise level that can be accepted rather than a 3000 year event which no living person can remember.

- 3 The maps Urban Planning Map1 and 2, Urban Hazard Map 1 and 2, Rural Planning Map 19 and Rural Hazard Map 19 seem to have an incorrect alignment for the Akatarawa River. This has been brought to the Councils attention in the past.
- We also note a paper road coming on to our property which has been long closed but which the Council still has on the maps. Could this be corrected?

Section 23 – Rules for Earthworks and Vegetation Clearance.

Farmers and Foresters have a relationship with the land which at times needs the ability to have farming/forestry as a permitted activity.

Enabling the farmer to maintain tracks and access roads from rain damage quickly, and to cut back encroaching vegetation, while also giving the farmer the ability to cut the back paddock from encroaching manuka, and tahwinau.
