DETAILS OF SUBMISSION

The specific provisions of the proposed Plan Change that my submission relates to are as follows:

Forest & Bird are the major conservation organisation in NZ and wish to "Give Nature a Voice" in regard to this proposed plan change. Forest & Bird recognise that many Upper Hutt residents will be impacted by this plan change and we are willing to mentor and work with all parties to assist with ensuring that the impact of these proposed changes are environmentally neutral.

We are particularly concerned about any work carried out in relation to The Mangaroa River that will have a negative impact on the environment of this river. We are willing to be included in any discussions and work on this river to ensure that water quality and the environment of the river is improved.

My submission is that:

Forest and Bird are concerned about the current health and state of the water ways in all parts of New Zealand and we have concerns within the Upper Hutt area. Many of our freshwater resources are in a poor state and need to be addressed to ensure they do not deteriorate any further and are brought back to being a healthy ecosystem to support all who use them. This includes surface water, ground water, estuaries and wetlands.

We support the plan changes as long as they have a neutral impact on the environment but we do oppose any major flood protection and water flow work being carried out on the Mangaroa, Whakaitki, Pukuratahi Rivers and the Wainui Stream.

Water will find its own path and follow its natural course when in flood, so any major flood protection work may have a limited effect.

Another major contribution to flooding is the sedimentation of streams and rivers from land run off, which will raise the height of the water in the river/stream and therefore increase the impact of any flooding of the river/stream. By using riparian planting along these water ways, the impact of flooding can be limited and the impact of sedimentation is lowered. Raising of stop banks may not be the answer.

We wish to see limitation of impermeable surfaces that will contribute to water run off contributing to increased water into water ways within the Upper Hutt City. This includes the development of rural land for commercial and residential purposes.

We would like to see the Waipango Wetland area protected and work done to restore this important and unique wetland.

Any work carried out in relation to the Southern Hills proposal must be environmentally neutral to avoid any flooding impact from this area.

We support the current ponding areas as designated on St Pat's land and the land adjacent to the Eastern Hutt Road south of the rail bridge up to Reynolds Bach Drive.
