### Making a Further Submission

Clause 8 of the First Schedule of the Resource Management Act outlines the persons that may make a further submission, being:

- (a) any person representing a relevant aspect of the public interest; and,
- (b) any person that has an interest in the proposed plan greater than the interest that the general public has; and
- (c) the local authority itself.

A further submission must be limited to a matter in support of or in opposition to the submissions that have already been made and which are summarised in this document. Submissions should be made in writing, in general accordance with Form 6 of the Resource Management Act (Forms, Fees, and Procedure) Regulations 2003.

## Submission

- The current definition for a temporary event is ambiguous as to whether or not it excludes temporary military training activities.
- An update is required to the definition for clarity, and is not considered to be significant.

#### Provision

• Chapter 2, 'Temporary Event' definition.

# Decision sought

- That the definition for Temporary Event' is amended as follows:
  - an organised event that is of a temporary nature, has a limited duration and that includes public entertainment events, cultural events and organised competitive sporting and recreational events, but excludes commercial promotional events <u>and temporary military training activities</u>.

### Submission

- The submitter states their overall support for the plan change. Believes provisions are well balanced between conformance, reducing disruption on surrounds, while still ensuring that an event can be run well.
