UNDER SECTION 94 OF THE RESOURCE MANAGEMENT ACT 1991

IMPORTANT - PLEASE READ THE FOLLOWING CAREFULLY BEFORE COMPLETING THIS FORM:

In considering applications for resource consent, the Upper Hutt City Council will take into consideration the views of parties which it considers to be affected by the proposal. This form provides the Council with a formal record of the consultation which has taken place in connection with an application for resource consent. The completion, signing and dating of this form identifies that -

Disclaimer - pursuant to section 104(3)(b) of the Resource Management Act 1991, the Council can not have regard to any effect on a person who has given written approval to the application. The fact that any such effect may occur may not be relevant grounds upon which the Council may decline the application.
